Official Rules: 2007 IYSA Soccer Expo Website Giveaway

- 1. How To Enter:** Consumers may complete an Official Entry Form as found on the Soccer Sights web site, or complete a hard copy Official Entry Form in person at the 2007 IYSA Soccer Expo on March 10th. No other method of entry will be accepted. All eligible contestants must have a valid e-mail address to participate in the contest, and all required fields must be answered accurately for the entry to be valid. Soccer Sights is the Sponsor of this contest.
- 2. Eligibility:** This Contest is offered only in the United States and is open only to legal U.S. residents, 8 years of age and older, who reside in and are affiliated with a competitive or recreational soccer club in the state of Indiana, Illinois, Michigan, or Wisconsin which currently has a club website. Employees of Soccer Sights, and its affiliated companies, subsidiaries, and the immediate families (spouses, and parents, children and siblings, and each of their respective spouses) and persons living in the same households as such individuals are ineligible.
